MORE ABOUT THE ADAMS TRACT

The recreational opportunities are equally impressive. The diversity of timber across the property provides excellent habitat for deer, turkey, and small game. One of the greatest assets is the extensive water frontage, boasting approximately 18,000 feet along the south side of the Noxubee River and an additional 18,400 feet along the east side of Hashuqua Creek. These waterways provide dependable year-round water, natural travel corridors for wildlife, and ideal turkey roosting habitat. During the initial inspection, an exceptional amount of turkey sign was observed throughout the property. While the tract has been leased for hunting for many years and no trail camera photos are available, the habitat and sign should help.

A small off-grid camp is located on the property, providing a comfortable base camp for hunting weekends or timber management visits. The cabin features sleeping accommodations for several people, a small kitchen and living area, and a back porch overlooking the surrounding timber. A nearby shed provides a convenient space for processing game after a successful hunt.

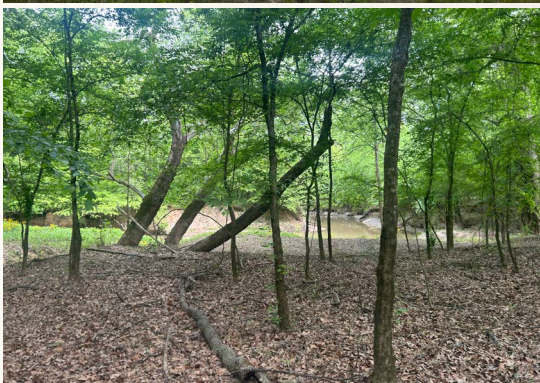

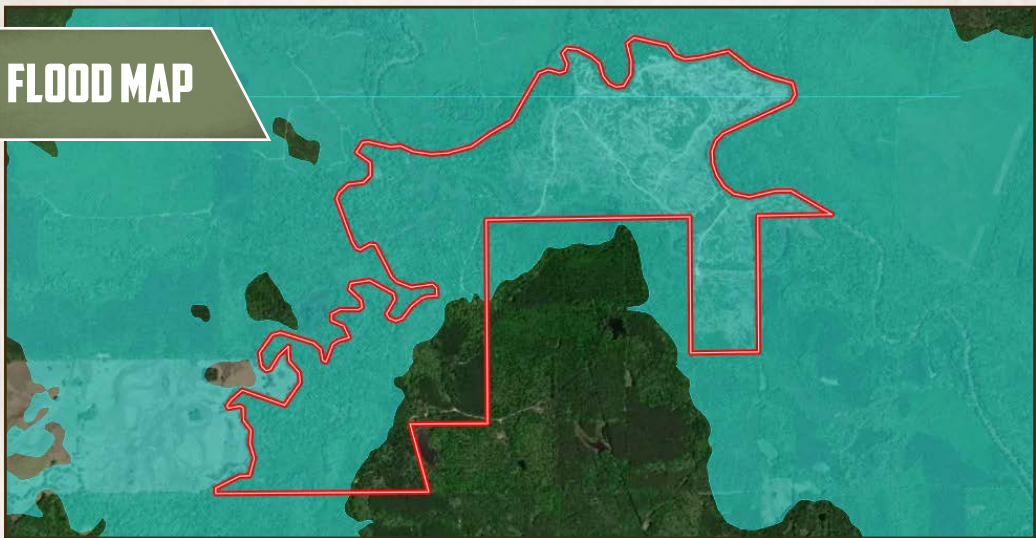

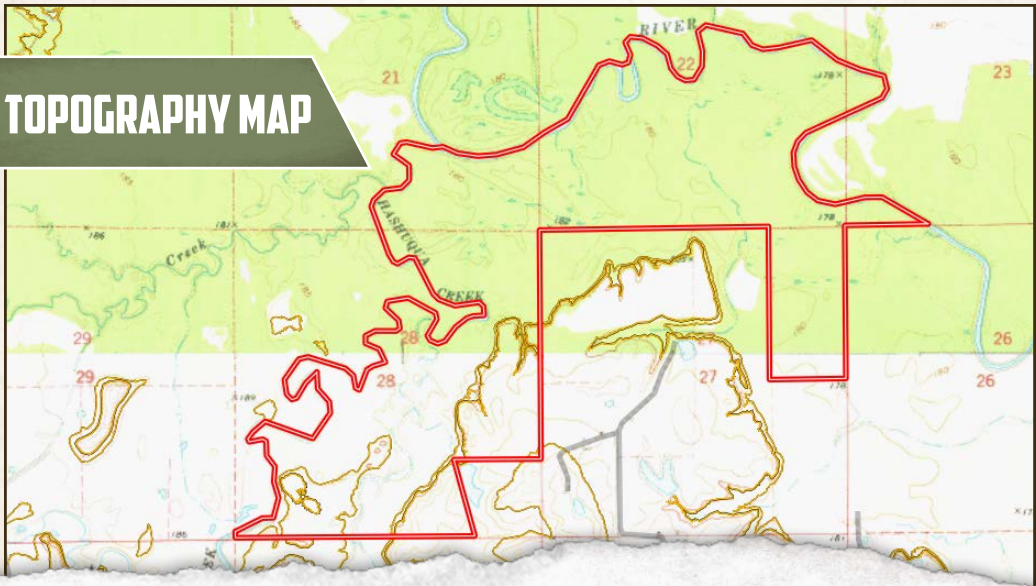

TOPOGRAPHY MAP



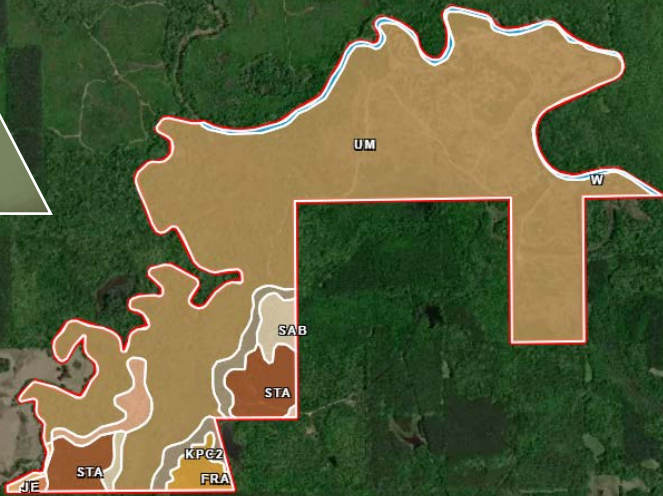

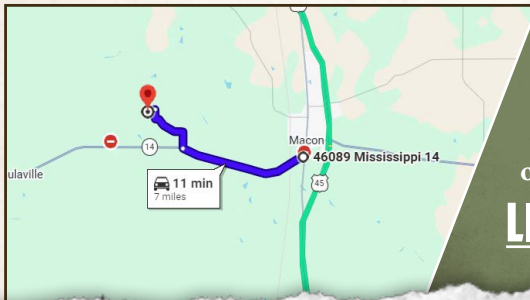
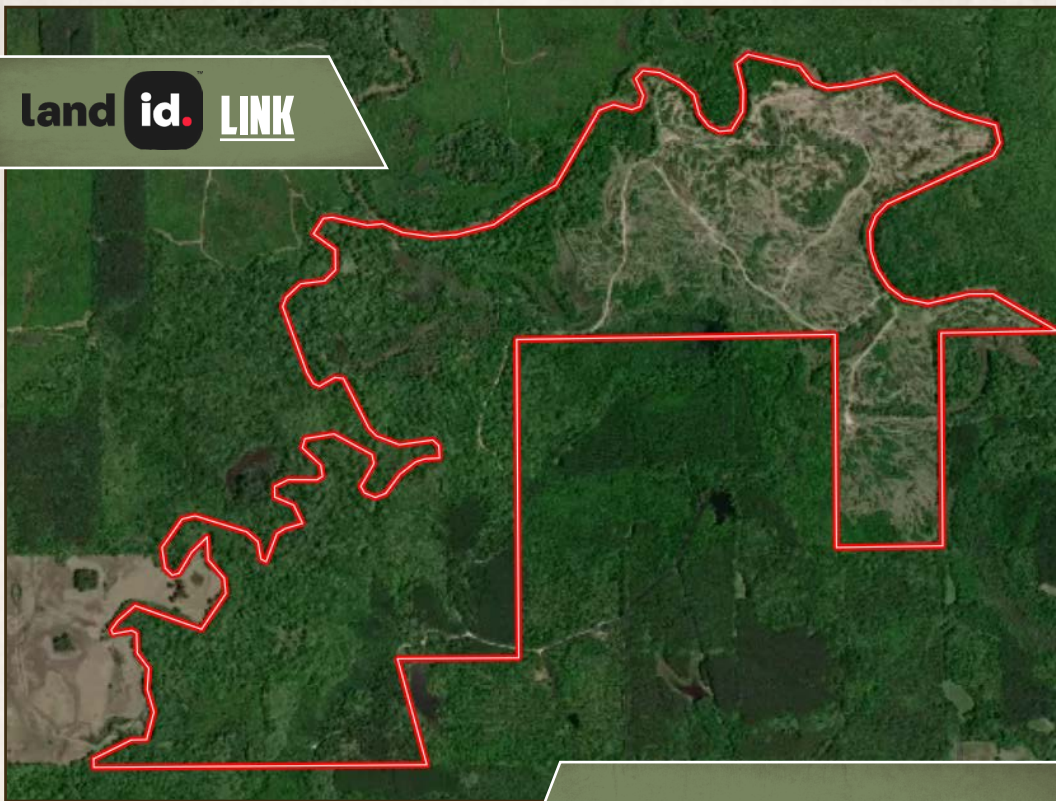
